MEMBERSHIP POLICY

The Camphill Village Trust intends to implement a series of reforms to ensure that it is fully compliant with all legal requirements both as a charity and as a care provider and that its first priority is the needs of its beneficiaries.

In particular it must:

- Comply with the regulatory advice issued by the Charity Commission.
- Comply with all statutory requirements relating to registration with the Care Quality Commission and with all requirements
 under the Health and Social Care Act 2008 and its associated regulations.
- Consider the concerns of local authorities who commission services from the Camphill Village Trust about the care that it
 provides for the beneficiaries and address those issues with the local authorities, implementing changes to its policies and
 procedures where it is necessary or desirable.
- Ensure that the care that it provides for its beneficiaries complies with current best practice, particularly, in relation to safeguarding.
- Comply with tax and employment law requirements.

The reforms will require:

admitted as a member.

- Complete financial accountability and transparency
- The implementation of new policies and procedures in relation to safeguarding and financial management, which will result in changes to the working practices and safeguarding culture within The Camphill Village Trust.
- Co-workers to become employed and changes to be made in that context to support the ability of the charity to comply with tax and employment law."

The reforms will have an impact upon co-workers, their families and other members of their households. The experience of the Trustees in implementing reforms gives rise to concern that some applications for membership may be motivated by opposition to the reforms.

The Trustees consider the proposed reforms to be essential for the future of The Camphill Village Trust. The Trustees have therefore resolved that it is in the best interests of The Camphill Village Trust not to admit to membership anyone who will, in their judgement, be affected by the proposed reforms unless it can clearly be shown that the prospective member will not oppose the reforms. The Trustees will therefore ask anyone who is likely to be affected personally by the reforms to identify that fact on their application form and to explain why the Trustees should admit them to membership.
